



Earnings Flash Note Qatari German Medical Devices 1Q2026

Qatari German Medical Devices Co. (QGMD)

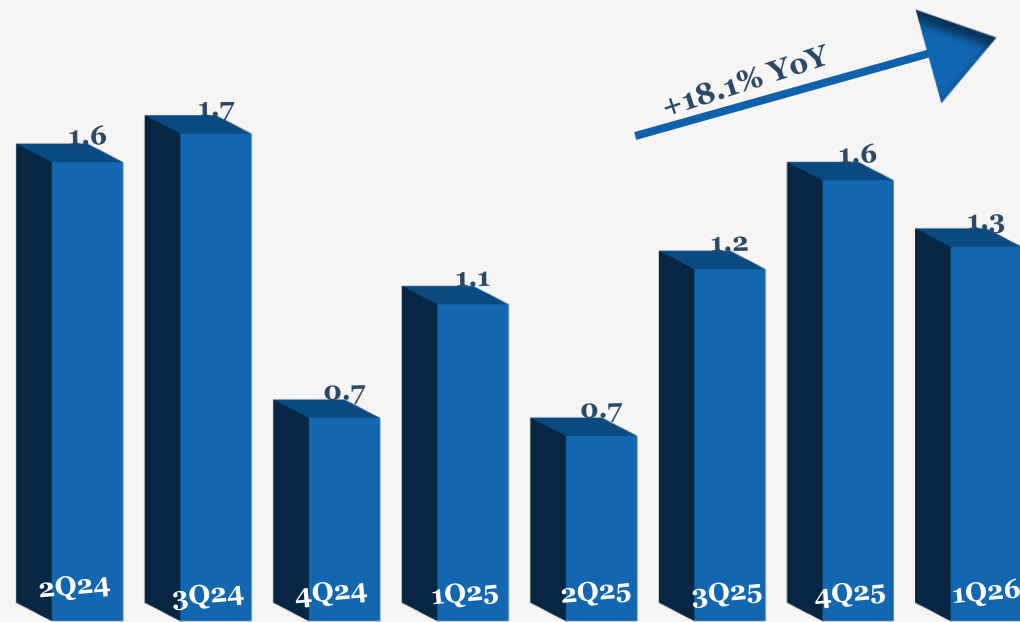
- > Net loss came to QR0.5mn in 1Q2026 vs. net loss of QR1.6mn in 1Q2025 and net profit of QR4.3mn in 4Q2025 due to higher revenue.
- > Total revenue came higher by 18.1% YoY (-15.0% QoQ) to QR1.3mn in 1Q2026.
- > Gross profit came at QR0.6mn in 1Q2026 vs. QR0.2mn in 1Q2025 and QR0.6mn in 4Q2025.
- > Operating loss came to QR0.5mn in 1Q2026 compared with operating loss of QR1.4mn in 1Q2025, and operating profit of QR4.3mn in 4Q2025.
- > For 1Q2026, loss per share came to QR0.005 vs. loss per share QR0.014 in 1Q2025.
- > As of 12th May 2026, the stock increased 1.9% YTD, outperforming the QSE Index, which was down by 2.2% YTD.

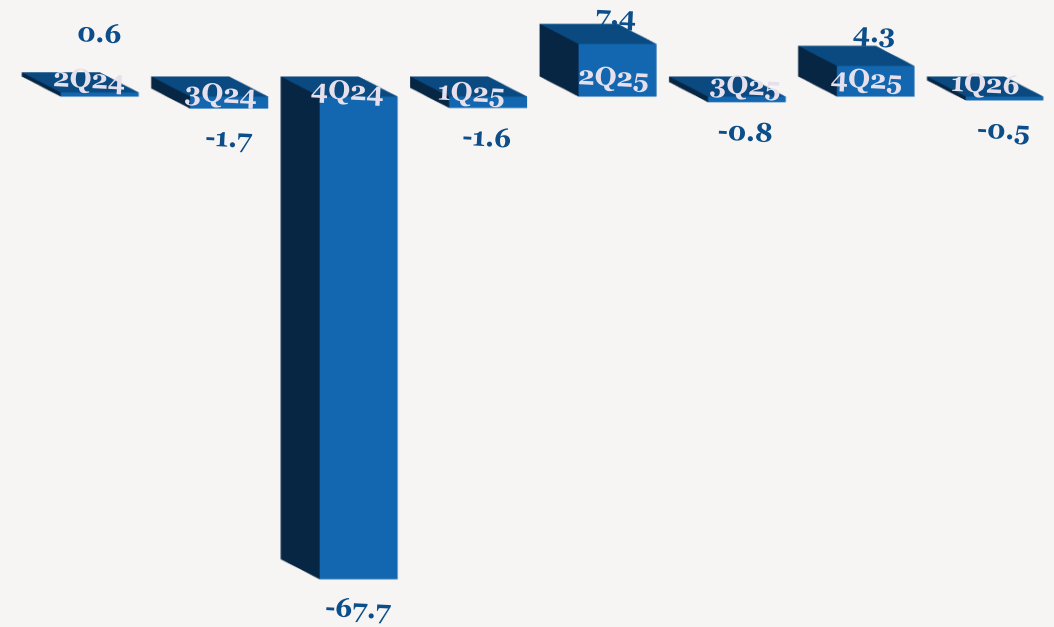

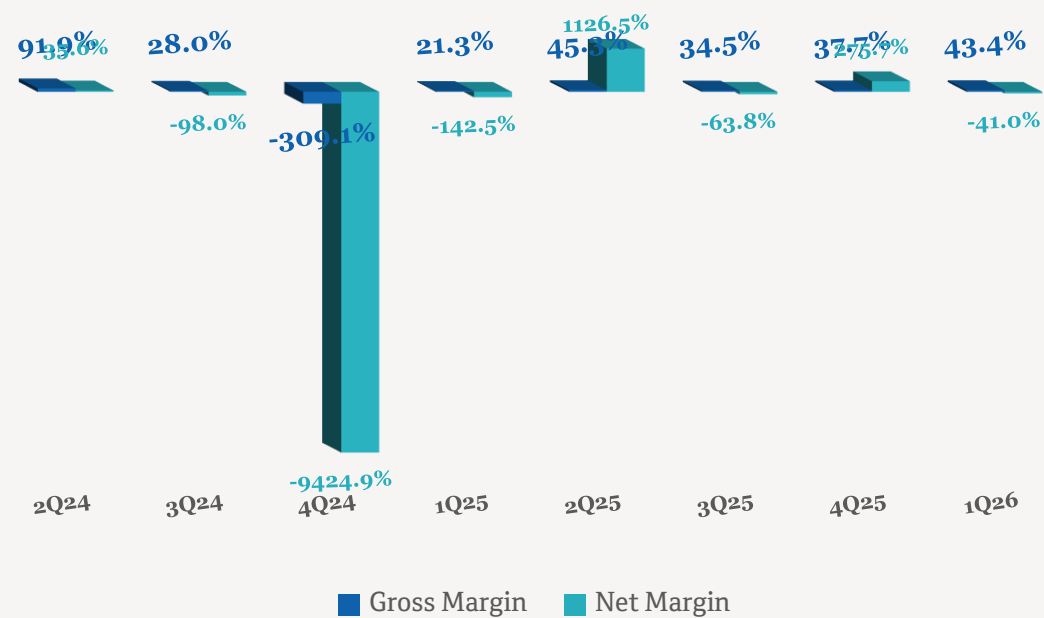
Quarterly Sales Trend (QRmn)



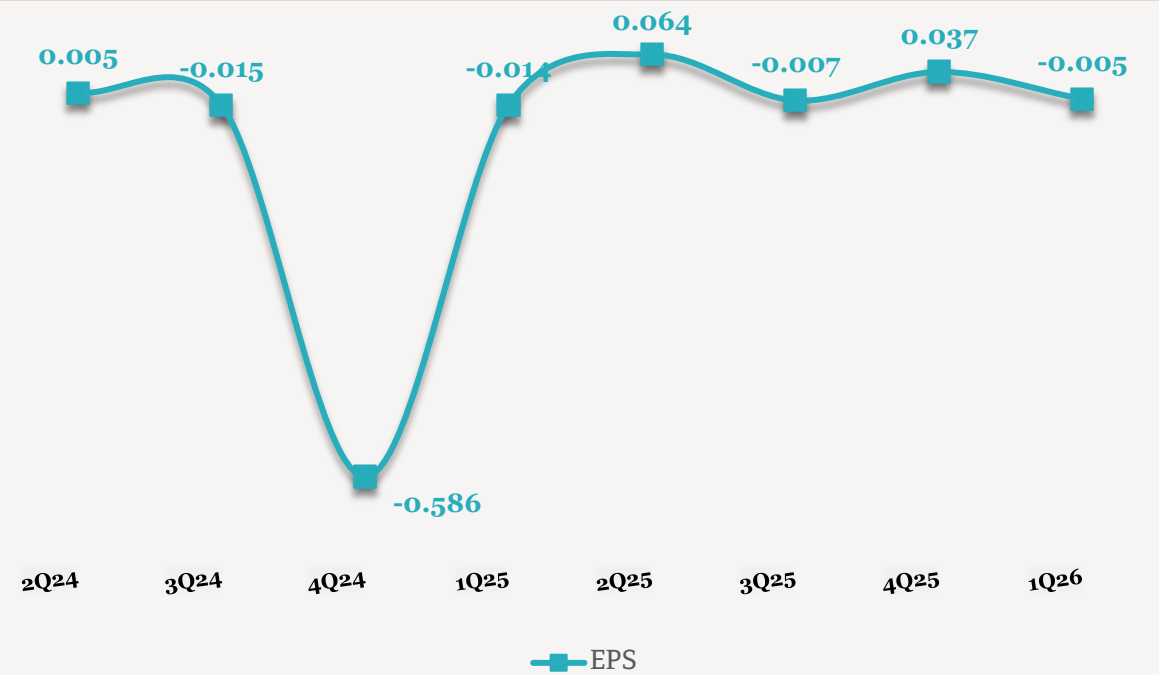
Quarterly Earnings Trend (QRmn)
