

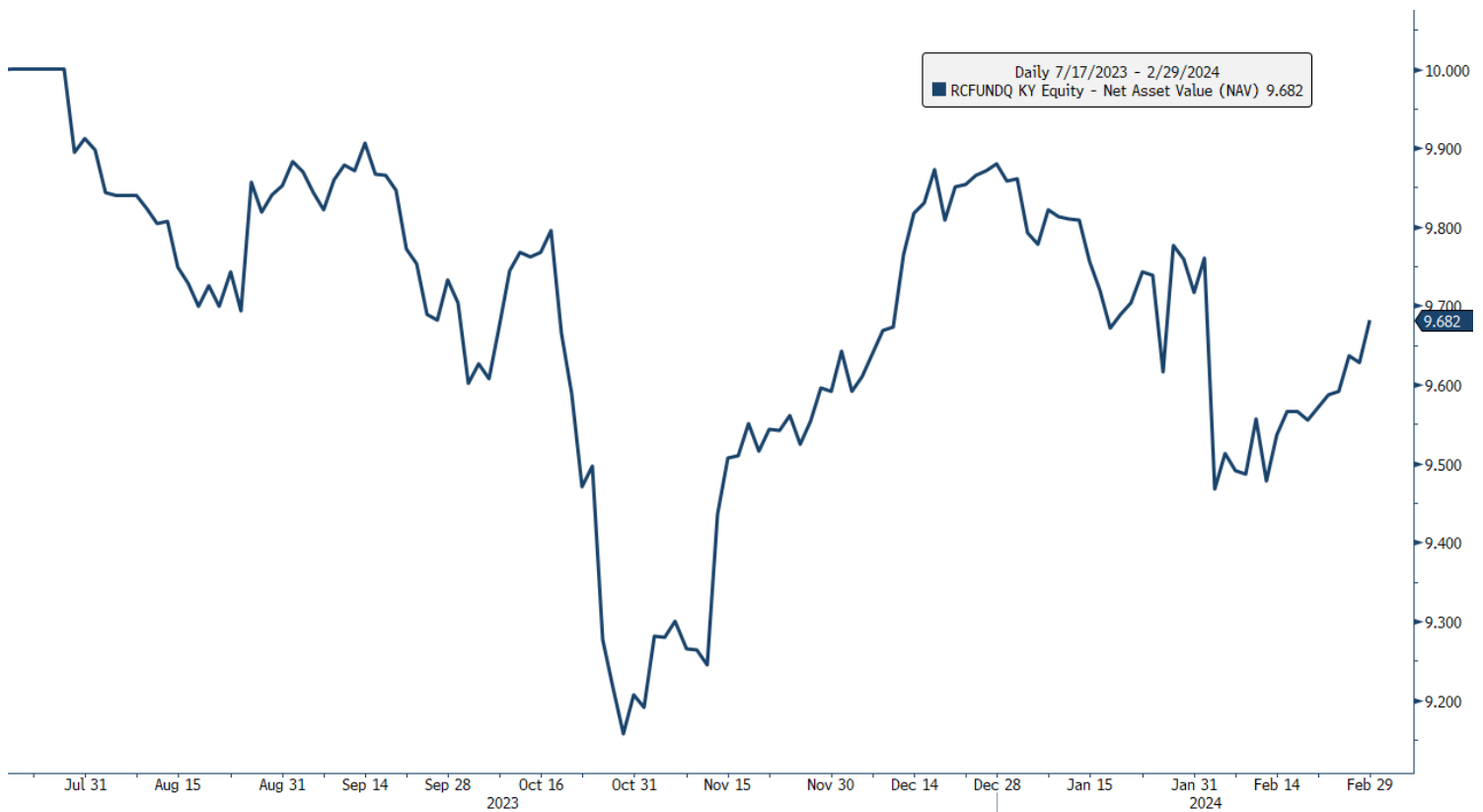
**Investment Objective**

The objective of the Fund is to generate a constant stream of cash flows by investing into Reverse Convertibles (RCs), Structured Notes, derivatives and cash or cash equivalent instruments.

**Investment Strategy**

The Fund will invest primarily in Auto-Callable Reverse Convertible and other Structured Notes related to equity, currency, commodities and indexes, derivatives and cash or cash equivalent instruments [for liquidity purposes]. The investment process is designed to harvest markets' volatility and convert it into cash flows whilst controlling the idiosyncratic risk of any single name investment exposure and the related business sector via concentration limits.

<b>Major Fund Allocation changes</b>	
<p>Three relevant events occurred during February 2024. New subscriptions were received for the RC Fund and these amounts were invested by issuing three RC notes bringing the total of single reverse convertible notes to 18. That increased the nominal amount invested over \$ 26 million. Second, we collected coupons for some of the notes that were due in this month. Third, the fund distributed the quarterly coupon (second since inception) on February 12, with a payment of \$0.25 per unit (equivalent to a nominal running yield of 10%) to our valued customers.</p>	
<b>General Considerations on the stock market</b>	
<p>In February global equity markets experienced positive trends, particularly in US stocks where the major benchmark increased by 5.2%. Headline and core inflation were pretty much aligned with consensus forecasts. Additionally, the volatility decreased from 14.3 at the end of January to 13.40 at the end of February 2024, which was favorable for secondary market pricing of the fund single notes. The funding rates increased by 2 basis points (from 4.7 to 4.9) for the generic US treasury 12-month's residual life with no material impact on RCs pricing.</p>
