

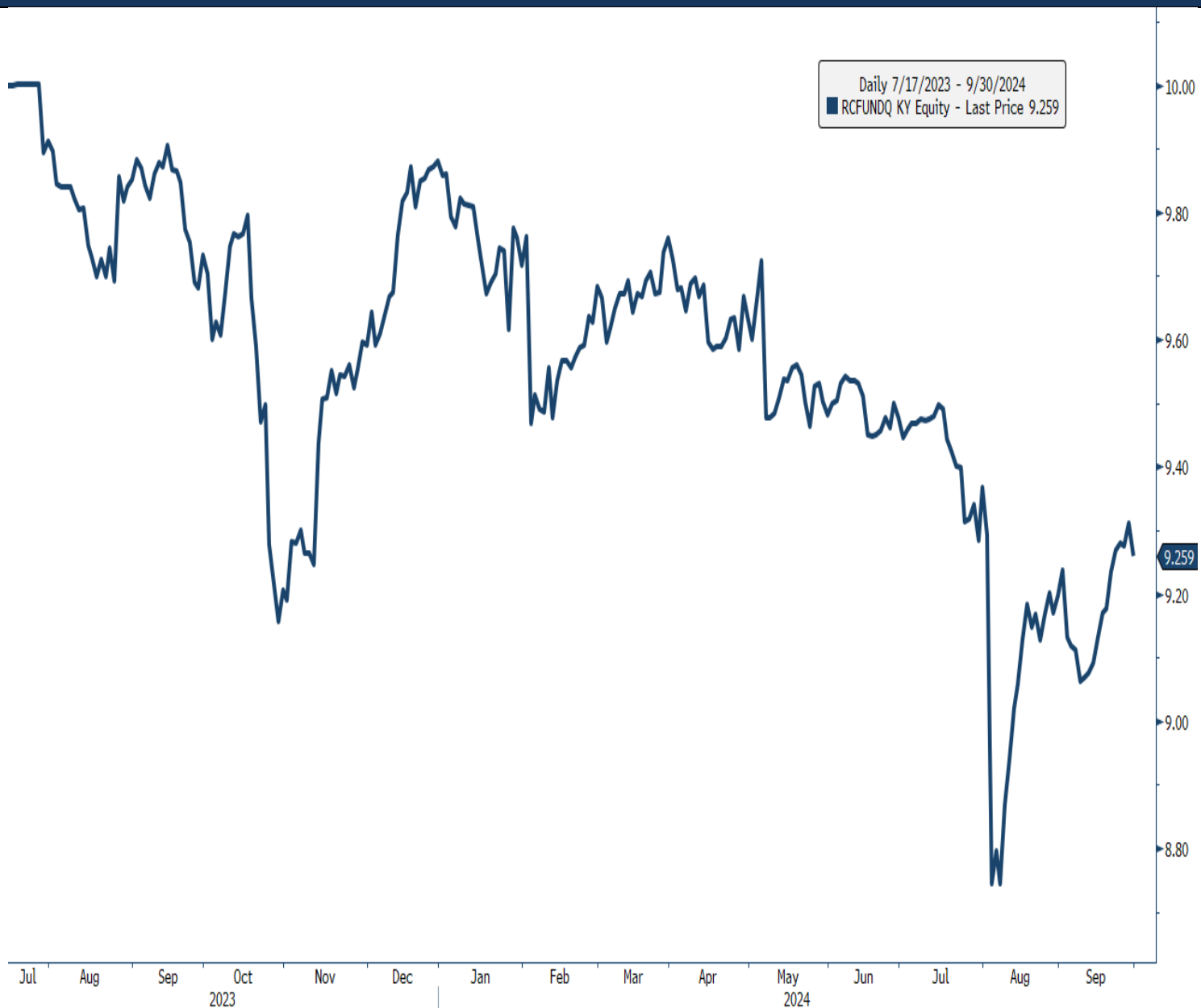
Investment Objective

The objective of the Fund is to generate a constant stream of cash flows by investing into Reverse Convertibles (RCs), Structured Notes, derivatives and cash or cash equivalent instruments.

Investment Strategy

The Fund will invest primarily in Auto-Callable Reverse Convertible and other Structured Notes related to equity, currency, commodities and indexes, derivatives and cash or cash equivalent instruments [for liquidity purposes]. The investment process is designed to harvest markets' volatility and convert it into cash flows whilst controlling the idiosyncratic risk of any single name investment exposure and the related business sector via concentration limits.

Major Fund Allocation changes

In September 2024, new subscriptions were received for the RC Fund, which were invested in two new RC notes. The RCF21 has been called and replaced with a new issuance of an RC note. As a result, the total number of our RC notes has increased compared to last month, bringing the overall count to 20 reverse convertible notes.

In accordance with the prospectus regarding the fund's obligations, the fund will pay the QNB management fees for the third quarter of 2024 in October, as the required amount was prepared by the end of September.

General Considerations on the stock market

The performance of the US equity reference index was positive by 3.1% in September together with a slight increase in average market volatility from end of August (15.0%) to end of September (16.7%): the drag on the fund performance was marginal.

During the same period, after the FED first rate cut, the dollar funding rate saw a material reduction to 4% compared with 4.4% of the previous month for the generic US treasury with a 12 month residual life. At the same time, this positive element was offset by the tightening of IG Banks borrowing cost.
